#### Village of Kirkersville Council Meeting Minutes

February 1, 2023

Mayor Ashcraft called the meeting to order at 7:00 p.m.

#### Agenda

It was moved by Kincaid, seconded by Engel to approve the agenda. Following vote on the motion was recorded: yea, 4; Davis, Engel, Forsthoefel and Kincaid. Nay, none.

#### Minutes

It was moved by Davis, seconded by Kincaid to approve the minutes of January 4, 2023. Following vote on the motion was recorded: yea, 4; Davis, Engel, Forsthoefel and Kincaid. Nay, none.

#### **Public Poll**

Randy Stoll, Engineer, said that Tyler owns property on E. Main and he would like to develop it. Due to the location of the sanitary sewer main and the depth of the line it would cost him eighty to one hundred thousand dollars. He is asking Council if they would approve a grinder pump on this property with the caveat that the property owner would maintain the grinder pump but the village would have access to the grinder pump if they had to get to it.

Council member Engel asked Tyler if he was going to build a maintenance building on the property.

Tyler said he plans on selling the property. He said the water table is so high that he cannot put a septic system in. The cost to install the grinder pump and connect a two-inch line will be about \$15,000.00.

Council member Davis said it sounds like a grinder pump is the way to go.

Randy Stoll said the village will need a maintenance agreement for this property and the pump will probably need to be released every few years.

Council member Forsthoefel asked will this be grandfathered in to whoever he sells the property to.

Brian said yes.

Council member Kincaid asked do we need legal language.

Brian said he will work on it.

It was moved by Kincaid, seconded by Engel to approve the grinder pump on Tyler's property contingent on a fully executed maintenance agreement. Following vote on the motion was recorded: yea, 4; Davis, Engel, Forsthoefel and Kincaid. Nay, none. Todd Ward said he is her tonight to give council an update. He said the annexation paperwork has been submitted and he will be going in front of the commissioners tomorrow. He said the maintenance agreement has been worked out with ODOT. He will be meeting with ODOT and the Fire District next week.

#### Mayor

Mayor Ashcraft said the fines for the month were \$927.00.

## BPA

Mayor Ashcraft said the BPA is getting a couple of screens made to catch the debris.

### **Police Chief**

Chief DeLawder gave his monthly report.

### Streets

Mayor Ashcraft said he needs approval for \$2.500.00 for gravel for the alleys. He said that gravel was put down on Turner and Arrowhead last week.

It was moved by Engel, seconded by Forsthoefel to approve \$2,500.00 for gravel for the alleys. Following vote on the motion was recorded: yea, 4; Davis, Engel, Forsthoefel and Kincaid. Nay, none.

## Fire Board

Council member Kincaid said there will be a four to five month delay in the start of Station. All issues have been worked out. Our February 9 meeting will be held at the Hebron Fire Station at 7:00 p.m.

### **Planning and Zoning**

Council member Engel said we did not have a quorum for our meeting in January. I have proposed to the Mayor that we have a subcommittee to work through the zoning code.

First Reading – Resolution 03-2023 – A Resolution adopting a statement of services and a statement of possible incompatible land uses and zoning buffer for a proposed annexation of +/-6.18 acres from Etna Township to the Village of Kirkersville and declaring an emergency.
