Mayor Ashcraft called the meeting to order at 7:00 p.m.

It was moved by Kincaid, seconded by Davis to approve the agenda. Following vote on the motion is recorded; yea, 5; Branham, Coe, Davis, Kincaid, and Slone. Nay, none.

Minutes

Discussion on the Minutes: Kincaid said he recused on the vote for tree service during New Business in September, and asked that the minutes be amended. The other Council members agreed with him.

It was moved by Branham, seconded by Davis to approve the minutes as amended of September 4, 2024. Following vote on the motion is recorded; yea, 5; Branham, Coe, Davis, Kincaid, and Slone. Nay, none.

Council member Davis read the following fund balances: General 154,901.96, Street 61,096.09, State Highway 32,532.53, Drug Law Enforcement 3,964.11, Indigent Drivers 400.00, American Rescue Plan 4,033.48, Enforcement and Education 80.00, Mayor's Court Computer 648.86, and Sewer Operating 395,818.61, for a total of \$653,475.64.

Council received a letter from Jessica Forsthoefel, 220 E. Main Street, requesting the Village to pay half of the cost of a sidewalk replaced in front of her house in 2016. Council Member Davis asked Attorney Zets what obligation the Village has in this matter. Zets said none; the property owner has the responsibility.

Following vote on whether to reimburse Jessica Forsthoefel for sidewalk replacement is recorded; Nay, 5; Branham, Coe, Davis, Kincaid, and Slone.

Mayor asked Council if they want to contract with the water district to provide water to the police station and the sewer plant. Council member Coe asked the benefit at the sewer plant. Mayor said they could wash filters, etc. Council member Kincaid said he is in favor because wells are drying quickly. Council member Davis asked how many wells have gone dry. Mayor said 20 or more, even though the water district says they aren't pumping their wells in town. It was moved by Kincaid, seconded by Branham to contract with the water district to provide water to the police station and the sewer plant. Following vote on the motion is recorded; yea, 5; Branham, Coe, Davis, Kincaid, and Slone. Nay, none.

Mayor said the Village-owned lot in town was surveyed and asked Council if they would like to put 4x4 posts with cable to mark the boundaries. The empty lot next to it has a few vehicles parked there. Council would like to see some costs. Mayor will have those at the next meeting.

Public Poll

Jim Raver asked if the wells going dry are clustered in any particular spots in town. He has not seen anyone at the wells behind him. Mayor said some are east side of town, some middle, and on 3rd and Channel Streets.

Judy Casto said her tenants, the Smoke Shop, need to pay permit fees for the new sign they hung.

A RESOLUTUTION TO CONSENT TO THE OHIO DEPARTMENT OF TRANSPORTATION RESURFACING WITH RELATED WORK AND DECLARING AN EMERGENCY.

SECTION 1. Project Description

Whereas, the Ohio Department of Transportation (ODOT) has determined the need for the described project:

Resurfacing with related work. Preventative maintenance work on bridges within the resurfacing limits. Scope of work within Village will include resurfacing.

NOW THEREFORE, be it ordained by the Council of the Village of Kirkersville, Licking County, Ohio.

SECTION 2. Consent Statement

Being in the public interest, the LPA gives consent to the Director of Transportation to complete the above described project.

SECTION 3. Cooperation Statement

The LPA shall cooperate with the Director of Transportation in the development and construction of the above described project as follows:

- 1. The LPA gives consent for the above improvement, and
- 2. The LPA further agrees to pay 100% of the cost of those features requested by the LPA which are determined by the State and Federal Highway Administration to be unnecessary for the project.

SECTION 4. Utilities and Right-of-Way Statement

If village owned utilities, within a corporation limit or in a private easement outside corporation limits, need to be relocated due to this ODOT project, the village will be reimbursed for any relocation work; ODOT will perform the coordination, relocation, and reimbursement which shall comply with the current provisions of 23 CFR 645 and the ODOT Utilities Manual.

If other public and private utilities need to be relocated due to this ODOT project they will not be reimbursed for relocation; with exceptions due to an easement, etc.

SECTION 5. Maintenance

Upon completion of the project, and unless otherwise agreed the LPA shall: (1) provide adequate maintenance for the Project in accordance with all applicable State and Federal law, including, but not limited to, Title 23, U.S.C., Section 116; (2) provide ample financial provisions, as necessary, for the maintenance of the Project; (3) maintain the right-of-way, keeping it free of obstructions; and (4) hold said right-of-way inviolate for public highway purposes.

SECTION 6. Authority to Sign

The LPA hereby authorizes Terry Ashcraft, Mayor, of the Village of Kirkersville is hereby empowered on behalf of he Village of Kirkersville to enter into agreements with the Director of Transportation which are necessary to complete the above described project.

SECTION 7.

It is hereby found and determined that all formal actions of this Council concerning and relating to the adoption of this Ordinance were adopted in an open meeting of this Council, and that any and all deliberations of this Council and any of its committees that resulted in such formal action were in meetings open to the public, in compliance with all legal requirements of the laws of the State of Ohio.

SECTION 8.

Council declares this to be an emergency measure immediately necessary for the preservation of the public peace, health, and safety of this municipality and the further reason that the Village needs to return this resolution to ODOT as soon as possible. Wherefore, provided this Ordinance receives the required affirmative votes of Council, this Ordinance shall take effect and be in force immediately upon passage by Council.

A RESOLUTON AUTHORIZING THE MAYOR TO ENTER INTO A CONTRACT WITH THE LICKING COUNTY BOARD OF COMMISSIONERS FOR REIMBURSEMENT OF LEGAL COUNSEL FOR INDIGENT DEFENDANTS FOR THE VILLAGE OF KIRKERSVILLE, LICKING COUNTY, OHIO AND DECLARING AN EMERGENCY

WHEREAS, in circumstances where an indigent individual is charged with a violation of ordinances of the Village of Kirkersville, and that person requests appointed counsel, the Municipal Court will appoint an attorney to provide for the individual's defense; and

WHEREAS, the county provides legal representation for indigent adults through and appointed system adopted in accordance with Ohio Revised Code Section 120.33, and

WHEREAS, the county may contract with a municipal corporation to provide legal representation for indigent persons charged with a violation or an ordinance of a municipal corporation for which the penalty or any possible adjudication includes the loss of liberty, and

WHEREAS, if there is no existing agreement between the Village of Kirkersville and the Licking County Board of Commissioners regarding reimbursement of the counsel appointed for the defendant, Licking County is unable to reimburse such attorney.

WHEREAS, this contract must contain terms in conformance with Ohio Administrative Code 120-1-09 and the parties must follow the Ohio Public Defender Commission standards and guidelines and the limits of the County Maximum Fee Schedule for Appointed Counsel in order for the County to obtain reimbursement for indigent defense costs pursuant to ORC 120.33 and 120.35, and pay the Village its appropriate share.

WHEREAS, an agreement, Resolution 122-86 for Indigent Defense services in Municipal Court with the Licking County Commissioners and the Village of Kirkersville reflecting the terms in conformance with the Ohio Administrative Code 120-1-09 was approved on January 25, 2024, and

WHEREAS, the term of this agreement shall be for one (1) year, January 1, 2025 to December 31, 2025 with the option for renewal for additional one year terms upon proper resolution of each entity agreeing to the one year extension and proper appropriation of funding for the new year.

NOW THEREFORE, BE IT RESOLVED BY THE VILLAGE OF KIRKERSVILLE, LICKING COUNTY, STATE OF OHIO, that

SECTION 1. The Mayor is hereby authorized to enter into a contract with the Licking County Board of Commissioners for Reimbursement of Legal Counsel for Indigent Defendants for the Village of Kirkersville.

SECTION 3. All legislation or parts thereof that are inconsistent herewith, be and are hereby, repealed and this resolution shall take effect according to law.

SECTION 4: It is hereby found and determined that all formal actions of this Council concerning and relating to the adoption of this Resolution were adopted in an open meeting of this Council, and that any and all deliberations of this Council and any of its committees that resulted in such formal action were in meetings open to the public, in compliance with all legal requirements of the laws of the State of Ohio.

SECTION 5. That this Resolution is declared an emergency measure necessary for the health, safety and welfare of the Village and its residents and specifically that this contact goes into effect January 1, 2025 and this resolution shall take effect immediately upon passage.
