

## Village of Kirkersville Council Meeting Minutes

November 5, 2025

Mayor Ashcraft called the meeting to order at 7:00 p.m.

### **Agenda**

It was moved by Engel, seconded by Kincaid to approve the agenda. Following vote on the motion is recorded: yea, 5; Coe, Davis, Engel, Kincaid and Slone. Nay, none.

### **Minutes**

It was moved by Coe, seconded by Engel to approve the minutes of October 1, 2025. Following vote on the motion is recorded: yea, 5; Coe, Davis, Engel, Kincaid and Slone. Nay, none.

It was moved by Kincaid, seconded by Coe to approve the minutes of October 13, 2025. Following vote on the motion is recorded: yea, 5; Coe, Davis, Engel, Kincaid and Slone. Nay, none.

### **Public Poll**

A gentleman from the Church asked if they would be able to use the village lot to park cars during their Thanksgiving gathering.

Council member Coe was worried about liability.

Brian said they won't have liability. Not much risk.

It was moved by Coe, seconded by Kincaid to allow the church to park cars on the village lot.

Randy Stoll said he will prepare an OPWC application for the Street Paving Improvement Project for Palmer Road West. Several pot holes could be forming. It has been 25 years since this was last paved. The application would be for a grant of \$151,897.01, loan of 21,960.06 for ten years and a local match of 26,142.93.

His will be under the small government section. If awarded, the funds will be available July 1, 2026. The traffic count was 300 cars in a 24-hour period.

## **Mayor**

Mayor Ashcraft said the fines for the month were 75.00.

## **BPA**

Dave White who owns the former Pinekirk Nursing Home is renovating the building to become a pizza place. The living quarters will remain unused. He is asking that he pay for only one unit of billing for the sewers instead of the four that he is currently being billed for.

Randy Stoll said Licking County set the occupancy at 35.

Vicki asked if this would set a precedent.

Mayor Ashcraft said how can we do this for one person and not for others.

Council member Coe said he should pay for the four units.

Council member Kincaid said this would be opening a can of worms.

## **Police**

Mayor Ashcraft said the Chief has to do some training. The radar cannot be used until next week.

## **Streets**

Council member Kincaid said Gro-Green will charge the same rate as last year for salting and plowing.

## **Fire Board**

Council member Kincaid said the tower truck is down. We sent letters to the Township about the TIF's. We are averaging 9,000 to 10,000 runs a year.

## **Planning and Zoning**

Council member Engel said they have not met. He said that trucks are turning left out of Speedway and they are not supposed to. Can something be done to stop that?

Mayor Ashcraft said he will talk with Speedway tomorrow. He said that Nate Green has someone looking at the Red rock property.
